The agency applying to be UCSI University's representative must be a recognised/certified agent by Agency Bodies such as ICEF, UniAgents, British Council, and/or EATC Australia.

All new agency applications must include at least 2 referrals for verification. Referral must be a manager or above at another institution. Information required for referrals includes:

****Agencies that do not have certification from the Agency Bodies must go through a 12-month probation period and must appoint staff (Agent Counsellors) to attend UCSI-Agent Training at UCSI and complete the Programme Assessment conducted by UCSI within 1 month of their appointment.**
